
2016-2017 CIVIL GRAND JURY SELECTION PROCESS INFORMATION

RECRUITING BEGINS:

In March 2016, the selection process for the 2016-2017 Stanislaus County Civil Grand Jury began; reach-out efforts were made to encourage county citizens to consider serving on the grand jury. Several hundred letters were mailed to:

- Randomly selected individuals from the Court's petit jury master list.
- Community leaders invited to nominate prospective jurors.
- Local newspapers.

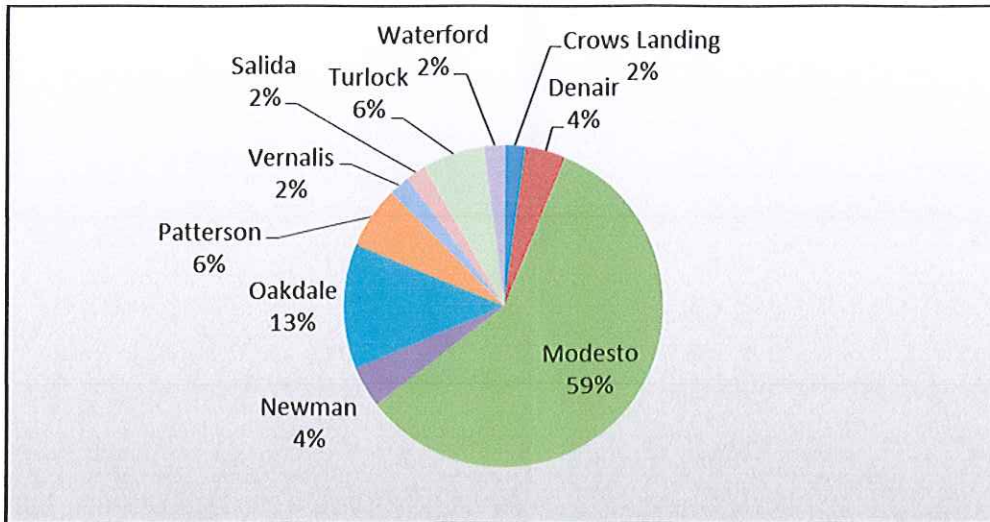

A total 48 prospective grand jurors submitted applications or were recommended to serve from the following sources:

- 3 jurors from the 2015-2016 Grand Jury asked to be carried over for second terms.
- 20 individuals from the Court's petit jury master list.
- 1 individuals nominated by community leaders.
- 24 applicants from the general public.

THE 2016-2017 GRAND JURY PANEL:

Three carry over jurors from 2015-2016 were appointed to serve a second term. Of the 48 new prospective jurors, thirty-three (33) completed the interview process. Thirty (30) names were presented to the Presiding Judge for the final drawing of the 2016-2017 Civil Grand Jury.

The final drawing resulted with the 19-member 2016-2017 Civil Grand Jury Panel consisting of the three carry over jurors, fifteen (15) individuals drawn at random, and the appointed Foreperson. Four (4) additional names were drawn as alternate jurors. Alternate jurors are called to serve if a regular grand juror resigns or is removed.

The 2016-2017 grand jury panel includes eight (8) females and eleven (11) males; representing the communities of Denair (2), Modesto (14), Oakdale (2), and Salida (1); demographic data detailed below.
