### SUMMONS

You are summoned to appear for **JURY SERVICE** on the date, time, and place indicated on the reverse.

#### One-Day or One-Trial

California has a **one-day or one-trial** term of jury service. This means that a trial juror serves for one day or for the duration of one trial. Statewide, the majority of jurors serve for just one day.

### EMPLOYER RETALIATION

State law prohibits discrimination or retaliation against an employee for taking time off to serve as a juror. (*California Labor Code*, section 230[a])

## JUROR INFORMATION

**FAILURE TO APPEAR:** Failure to appear as summoned could result in a \$1,500.00 fine, a jail sentence or other legal consequences.

**CHILD CARE:** California law does not allow excuse from jury duty because of child care. However, you may request a one time postponement.

**SCHOOL:** California law does not allow excuse from jury duty while attending classes. However, you may request a one time postponement.

**TRANSPORTATION:** You may use this summons as a complimentary bus pass to and from the courthouse. See bus pass and information on reverse side.

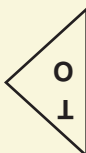
